- SAP EHP-8 contained functional enhancements, new user interfaces, and enterprise services that GFEBS and GFEBS-SA could use to optimize Army business processes.
- Scope of the UAT ensured identifying business processes and system events that had an adequate exposure to the EHP-8 enhancements.
- Test models detailed what was to be tested and served as the means of achieving "user acceptance".
- Defects were identified, formally reported, and resolved.
- The Government client certified the UAT and added the final seal of acceptance.
